### **Affordable Houses.**

Due to local concern the Environment Agency are currently scrutinising the latest Odour Management Plan in more detail than they have done with A D Plants previously and once this has been accepted progress can then be made on the Environment Impact Assessment

### **Broadband**

The wiring for Broadband has now been installed at the Green and it should be ready to go in the spring. We might be part of a pilot scheme which could make it earlier. Unfortunately the turf had to be dug up and has made a mess but hopefully this will settle down during the winter and come good for next spring.

### **Water on the A535**

The ongoing saga with the water running across the main road at Saltersford has still not been resolved and we are now into the 3<sup>rd</sup> winter of running the risk of a nasty accident caused by an 'ice slick' during bad weather. At last BT have taken responsibility for the problem and we have informed them of the dangers of a serious frost. No doubt it will have to go through lots of different layers of bureaucracy at BT before someone has some common sense to get it sorted

### **A535 Speed Review**

Following the Route Management Strategy of the A535 route from Chelford Roundabout through to Holmes Chapel, Cheshire East Highways are proposing a number of speed limit reductions along the route itself as well as in the middle of Twemlow itself.

It is suggested that the A535 between Twemlow and Terra Nova school becomes '50' and this will continue as far as Chelford until it gets to the current '40' limit.

It is also suggested that the '30' limits are as follows

A535 from just below Bank Farm to where the current 50 sign is on the way towards Chelford.

Twemlow Lane until just after the bad bend and on the straight passed Blue Slate Farm

Goostrey Lane up to the boundary of the ex MOD site.

Forty Acre Lane to between Acres Croft and The Acres Farm and including 'The Yellow Broom Triangle'

### **Community Resilience Plans**

This is a new initiative from Cheshire East to help communities help one another if there are any major incidents, gales, power cuts etc. in the area. We hope to organise a meeting in the New Year to see if anyone is willing to take part.
