## NEIGHBOURHOOD PLAN - HELP NEEDED!

At our forthcoming meeting on Monday 9th November, we will be joined by Lucy Hughes from Cheshire Community Action who consult parish councils on neighbourhood plans. We will also be joined by members of Cranage Parish Council. Preparing a plan can help us play a greater role in shaping the future of our area by setting our own local planning priorities and aspirations within the broader planning system. Once complete, our plan will sit alongside the Councils local plan (which has not yet been approved) and can be used to make decisions on new development proposals. This is of great importance as we strive to safeguard the interests of the parish. We would like to begin the journey of forming a plan but we need your help. Please come to the meeting to see if you can help or assist in any way.

## COMMUNITY SPEEDWATCH TEAM

At our meeting on Monday 3rd August, the Parish Council voted to purchase a speed gun for use within the parish. Following the arrival of the gun, training has been provided by our local PCSO to members of the Parish Council and residents. Any residents interested in joining the community speedwatch team should contact the clerk, who can arrange further training on how to use the Parish Council's speed monitoring device. From this month, the 30mph speed limit will be enforced by the speedwatch team. It should be noted that during the first training session, 12 motorists were recorded as speeding and will be sent formal warning letters.

## A.D. PLANT APPLICATION REFUSED

The long running planning application (12/0705W) for a possible Anaerobic Digester waste and power plant at the abandoned MoD site in Twemlow was settled on 26 August, when the Strategic Planning Board of Cheshire East Council refused it planning permission, by a vote of 10 against with 2 abstentions. This followed the decision by the Environment Agency in July 2014 to refuse an environmental permit to operate such a plant in this location in close proximity to housing. Three years ago, Twemlow Parish Council stated that it had no objections to the original proposals, but set a number of conditions. The Parish Council pressed, in particular, for an Environmental Impact Assessment (EIA) to be conducted in view of the likely increase in traffic, smells and noise. In the light of the Environment Agency's refusal of a permit, Twemlow Parish Council resolved not to support this application "until it gets support from the Environment Agency." The Environment Agency stated: "the odour management plan and subsequent versions have not satisfied the agency that this facility will be able to control odour emissions," and the applicant "would not be able to comply with the conditions on odour which any EA permit would stipulate." The Health Protection Agency had expressed concerns for public health and, in its report to Councillors, Cheshire East's Environmental Protection team recommended refusal of planning permission, stating: "the Department can no longer be satisfied that public health will not be adversely impacted by this proposal". The Strategic Planning Board refused this application on numerous specific planning grounds.

## NEW BUSINESS PLAN FOR TWEMLOW

The Parish Council approved a new business plan in September, which is now available to view on our website.

Our vision is : To maintain Twemlow as a desirable and attractive rural parish in which to live, offering a good quality of life for all residents and businesses. Any future changes or developments shall be determined for the long term benefit of the whole community.

The objectives of the business plan are : To safeguard the interests of all parishioners - To prevent uncontrolled speculative development in Twemlow - To act as a precursor to a Neighbourhood Plan or Parish Plan - to maintain Quality Status for Twemlow Parish Council.
